Below you will find the information that explains how we collect personal data in the process of communicating with you through the "Facebook" platform.

WHAT INFORMATION DO WE COLLECT ABOUT YOU?

Through the "Facebook" platform we do not have direct access to your personal data, with the following exceptions:

- We can only contact you if you have previously contacted us;
- At any interaction with our content or by clicking our "Like" button, we can access your Facebook profile and the personal data you have publicly available;
- When you post a photo and check in at our hotel, the page administrators can access your photo;
- If you share a post on our personal profile, or if you share a personal post on the timeline of our hotel page, or recommend our hotel to another person, then the page administrators are notified about your activity on the hotel's Facebook page.

HOW DO WE USE YOUR INFORMATION?

All the aforementioned information about you is accessible only to the hotel page administrators. We do not sell or send your data to other entities.

MARKETING

Occasionally it is possible to use the targeted promotion service offered by the Facebook platform, under the conditions set by the Facebook company, which you can access from the "Terms and conditions" sections, respectively "Privacy policy".

You can always opt out of receiving messages from us through a simple unsubscribe process. („unfollow”/ ”unsubscribe”).

ACCESS TO INFORMATION, DATA RECTIFICATION, AND COMPLAINTS
