on the application of the provisions of the General Regulation for the Protection of Personal Data while using the cosmetic services offered by Teleferic Spa Center

We, at SC TINT SRL are interested in respecting your privacy and, therefore, our privacy policy and all the related procedures comply with the General Regulation for the Protection of Personal Data. CONFIDENTIALITY NOTICE

The TELEFERIC GRAND HOTEL belongs to the trade company SC TINT SRL. Below you will find the information that explains how we collect personal data in the process of accessing the spa area and using the cosmetic services offered by Teleferic Spa Center.

WHAT INFORMATION DO WE COLLECT ABOUT YOU?

We collect the following data: first name and surname; address; Optional: phone number, email. In addition, we collect data on your health status, from the perspective of its compatibility with the recommended cosmetic treatments.

WHAT IS THE PURPOSE OF COLLECTING INFORMATION ABOUT YOU?

We collect the above data for the following purposes:

- To update your contact information;
- To provide you with appropriate cosmetic services;
- Optionally, with your written consent:
 - o To send you direct marketing messages and other communications regarding the products and services offered by TINT SRL;
 - o For conducting market research and opinion polls or for various other types of communication.

YOUR CONSENT

We ask for your consent to process your personal data, including special data, regarding your health status; we need this consent in order to have access to information about your health, because we must make sure that you do not suffer from any condition that may conflict with the facilities offered in the spa area and with the cosmetic treatments that will be recommended (allergies, dermatological disorders etc.)

HOW DO WE USE YOUR INFORMATION?

All this information is necessary for us to be able to give you access to the facilities in the spa area and to our cosmetic services, specific to the SPA center.

We do not sell your data to other entities. The data is physically stored for a period of 90 days after your last presence at our SPA, and then they are shredded at the paper shredder or in our IT systems for an unlimited period.

INTERNATIONAL TRANSFER OF PERSONAL DATA

The personal data you fill out are not sent, under any circumstances, abroad.

MARKETING

We can keep you updated with our offers, if you provide us with your personal e-mail address and give us your consent in this regard. If you have accepted this, you may at any time opt out of receiving offers from us through a simple unsubscribe process.

ACCESS TO INFORMATION, DATA RECTIFICATION, COMPLAINTS

We assure you that all your rights are respected and that your personal information is fully protected. They are securely stored in our systems so that no unauthorized person can access them.

The data regarding your health status are accessible only to the specialized personnel within the Spa and are not public.

You have the right to request:

- Access to your personal data stored in our IT systems;
- Rectifying or deleting your personal data;
- Restrict the processing of your personal data;
- Your opposition to the processing of your personal data;

If you have given your consent for us to process your personal data, you have the right, at any time, to withdraw your consent, but without this affecting the legality of the processing of the data performed on the basis of your consent, before withdrawing it.

Your requests must be made in the form of an inquiry. If you would like to send us your inquiry in electronic format, it must be sent to us from a verifiable email address. The contact details of the department responsible of the protection of personal data are:
