CONFIDENTIALITY NOTICE

The TELEFERIC GRAND HOTEL belongs to the trade company SC TINT SRL. Below you will find the information that explains how we collect personal data in the process of hotel reservation for a stay through the www.telefericgrandhotel.ro website.

WHAT INFORMATION DO WE COLLECT ABOUT YOU?

In order to make an online reservation using the platform of TINT SRL we need the following personal data: first name and surname; home address, telephone number; your email address. To guarantee the reservation we ask you for some information about your bank card. The phone number and the e-mail address are required to inform you about the stage of solving your reservation request.

HOW DO WE USE YOUR INFORMATION?

All this information is legally required to guarantee your reservation and to stay at our hotel. To confirm the reservation we will check the bank card used by you for guarantee, with the help of the bank ING BANK AND BANCA TRANSILVANIA, the partners that provide us with this service. If, for various reasons, we will need to contact you before staying at our hotel, we will do so at the email address you have provided to us.

We do not sell or send your data to other entities. They are stored on our servers for an unlimited period of time.

MARKETING

We will not send you any information about our hotel because we have no way to directly contact you. During the check-in procedure, if you wish, you can give us your consent to keep you up to date with our offers, sent on your personal e-mail address. If you have accepted this, you can at any time opt out of receiving offers from us through a simple unsubscribe process.
