Below you will find the information that explains how we collect personal data in the process of hotel reservation through Booking.com and other OTE.

WHAT INFORMATION DO WE COLLECT ABOUT YOU?

Booking.com sends us all the information you have personally filled in on their website, except your private email address.

HOW DO WE USE YOUR INFORMATION?

All this information is legally required to guarantee your reservation and to stay at our hotel. To confirm the reservation we will verify the bank card used by you for guarantee with the help of ING BANK AND BANCA TRANSILVANIA, the partners that provide us with this service. If, for various reasons, we will need to contact you before staying at our hotel, we will do so only through the generic email address provided by Booking.com. We do not sell or send your data to other entities. They are stored on our servers for an unlimited period of time.

MARKETING

We will not send you any information about our hotel because we have no way to directly contact you. During the accommodation procedure, if you wish, you can provide us directly with your personal e-mail address and you can give us your consent to keep up to date with our offers. If you have accepted this, you can at any time opt out of receiving offers from us through a simple unsubscribe process.

ACCESS TO INFORMATION, DATA RECTIFICATION, COMPLAINTS

We assure you that all your rights are respected and that your personal information is fully protected. You have the right to request a copy of the information we have about you, to request the rectification or deletion of such data, or to request the restriction of data processing.
